

## ★ Lucky Earning Track – Website Requirements

### ◆ Admin Section

Admin should be able to view all invoices and all sent email's templates inside the Admin Panel.

Admin should be able to view all invoices and all sent email's who we're received

Admin should be able to view all invoices and email's of active,passive, we'll say etc.. ...

Admin should be able to make changes anywhere as required.

Admin should have full control to adjust layout alignment (up, down, left, right) throughout the panel.

Admin must be able to edit/update anytime

---

### ◆ Certificate Section

When a user clicks “Download Certificate” after completing a course OR in separate section of certificate:

1. A popup must appear with questions set by Admin.
2. If the user answers correctly → show a Success message → certificate downloads automatically.
3. Each course should have its own set of admin-created questions.
4. If answers are wrong → show Try Again until correct.

Admin must be able to edit/update anytime

---

### ◆ Payout Section

The system must calculate affiliate earnings from Monday to Sunday.

Payments will be released on the next Wednesday or Thursday.

Affiliates must be able to track weekly active + passive earnings.

System should calculate active and passive separately and also show the total earnings in the next column.

Email Templates should be custom

Only active → show active earnings.

Only passive → show passive earnings.

Both active + passive → show both clearly in one email.

WhatsApp Notification and Mail

Automatically send a message:

> “Dear learner, you earned ₹\_\_\_\_ from \_\_ to \_\_. It has been credited to your bank account.” Like this we will provide

#### Weekly Payment Mail Must Include

> “Your weekly earnings from [start date] to [end date] have been credited to your bank account.”

#### Admin Flexibility

Admin can change payout week range (example: Monday–Wednesday).

Admin must be able to edit/update anytime

#### TDS Integration

If TDS applies, the system must auto-calculate TDS when generating payouts.

Email and WhatsApp messages should show:

Earnings

TDS deduction

Final credited amount

Admin must be able to edit/update anytime

---

#### ◆ Reward System (Admin Panel)

Admin can add rewards for affiliates with custom descriptions.

Admin must be able to edit/update anytime

A custom name such as “Rewards / Effort / Dedication/Reels/Menor/Instructor” should appear above Today’s Earnings only when a reward is added.

Once reward is paid, this label disappears.

Rewards appear separately in a Rewards Wallet/Reels Wallet/Menor Wallet/Instructor (not part of active or passive income).

Users can see reward amount + description in their dashboard/separate section.

#### Reward Payment Email

> “You received this reward for [reason]. Amount ₹\_\_\_\_ has been credited to your bank account.”

Admin must be able to edit/update anytime

#### ◆ Admin Mail Section

System sends emails like “You have successfully enrolled, you can access your course.”

Admin must be able to view all sent emails and how many users received them.

Invoice must be attached to these emails.

Invoice style and color should match the website logo gradient.

Admin must be able to edit/update anytime

---

- ◆ Affiliate Link Section

The commission chart (package, price, active, passive) should be editable only by admin.

Admin must be able to edit/update anytime

---

- ◆ Social Media Preview

When the website link or affiliate link is shared on WhatsApp or any social media, our logo must appear above the link.

Fix the preview metadata accordingly.

Admin must be able to edit/update anytime

---

- ◆ Mentors / Instructors / Partners Section

Create 3 separate sections for Mentors, Instructors, and Partners — each with a unique design.

Instructor photos should move slowly and stop when hovered or clicked.

Admin must be able to edit/update anytime

---

- ◆ Active & Passive Section

Payment must be done together (not separate).

If only passive → pay passive only.

If only active → pay active only.

If both → send one combined email.

Notifications (Dashboard or Email)

“Active Referral Income Earned”

“Passive Referral Income Earned”

These must apply to the weekly payout tracking system.

Admin must be able to edit/update anytime

---

- ◆ Payment Gateway

Integrate:

✓ Razorpay ✓ PayU

Both must support automatic and manual settlement.

If we set gst or normal price, user see what actually they are paying including gst or not if we set or not.

Admin must be able to edit/update anytime

---

- ◆ Home Page – Welcome Message

Show animated message: “Welcome to Lucky Earning Track”

Background: curved white design + light shake effect.

Admin should be able to change the text anytime.

Message automatically disappears in 4–5 seconds.

Admin must be able to edit/update anytime

---

- ◆ User Section – Social Links

Users can add their social links (YouTube, Instagram, LinkedIn, Facebook, etc.).

Users can set a custom title for each link.

All links must be clickable and visible to admin.

---

- ◆ Menu Bar Enhancements

Add downloadable items near “About Us / Our Courses / Contact Us”:

Presentation PDF

Introduction PDF

Admin should be able to add more items anytime.

And Add Wall of Frame near “About Us / Our Courses / Contact Us with dynamic design:

Photo,Name,Description on click

- ◆ Mail Templates

Create all custom mail templates matching website logo and gradient colors.

When mail goes it contains invoice

Admin must be able to edit/update anytime

---

- ◆ Admin – Account Blocking

Admin can block or suspend any user.

When a blocked user logs in, show:

“Your account is blocked/suspended due to violation. Contact support via WhatsApp or email.”

When a user is blocked, their sponsor should receive zero commissions going forward.

---

- ◆ Admin – Add Course / Training Links

Admin can add video links from Drive, YouTube, Instagram, etc.

Videos must play inside the website, without opening external platforms.

Admin must be able to edit/update anytime

---

- ◆ Course Section

Similar to the training playlist, admin can decide the order of courses (first, second, middle, last)

---

- ◆ Admin – Affiliate Activity Tracking

Admin should see:

Login / logout times with date & time

KYC completion date/time

Course watched date/time

Certificate download date/time

Admin must be able to edit/update anytime

---

- ◆ Home Page – Review Videos

Add review video slider above Testimonials.

Videos move right-to-left slowly.

On click → video stops and plays.

When idle → movement resumes.

Admin must be able to edit/update anytime

---

- ◆ Certificate Section

When user clicks download certificate → open popup quiz.

If correct → success → download.

If wrong → retry until correct.

Admin must be able to edit/update anytime

---

- ◆ Dashboard Notifications

Admin can send notifications to all users OR specific users.

Notifications should appear on dashboard near the profile picture.

---

- ◆ Course Enroll Section

When user clicks “Enroll,” open a new page.

Play a partial demo video.

To watch full course → user must enroll and complete payment.

After payment, redirect to course page.

Admin should be able to add more items anytime.

---

- ◆ Home Page Video Section

Home page video under banners must play cleanly with perfect margins and no black spaces.

Admin should be able to add more items anytime.

---

- ◆ Menu Bar – Editable Content

Admin must be able to edit/update anytime:

About Us, Contact Us, FAQ, Testimonials, Disclaimer, Privacy Policy, End User License Agreement, Refund Policy; Terms & Conditions

---

## ★ Subscription System Requirements (Very Important)

Subscription is Course-Wise

Admin must be able to edit/update anytime

Subscription price depends on the course the user purchased.

For each course, admin will set prices for:

1 Month

3 Months

6 Months

12 Months

Prices are different for each course, 15 days free After user freshly joined user can access anything.

---

Features Unlocked ONLY if Subscription is Active

Admin must be able to edit/update anytime

When subscription is active, user gets access to:

Affiliate Link

Affiliate Dashboard

Active Income

Passive Income

Company Trip Eligibility

Company Events Eligibility

Partner Program Eligibility

More upcoming earning features

More upcoming features, we will say

A popup must show these benefits before subscription purchase.

If No Subscription or Subscription Expired

User can: ✓ View course

✓ Learn

✓ Download certificate

✓ See leaderboard

✓ See live offers, attend meeting

✓ See target earning

✓ Access to training, webinar, watch videos

User CANNOT: they will not access

- ✖ Use affiliate link
- ✖ Earn active income
- ✖ Earn passive income
- ✖ Access earning dashboard
- ✖ Participate in events or trips
- ✖ Use partner program
- ✖ More upcoming features
- ✖ Participate in live offers,rewards'

◆ USER SECTION – Hidden Course Module (Professional Version)

Add one hidden course that does NOT participate in the active or passive commission structure.

Users should still be able to purchase this hidden course normally after login.

When a user purchases this hidden course:

A separate custom email must be sent.

A separate invoice template must go along with the email.

(Mail + Invoice must be combined and unique for this hidden course only.)

Admin must have the ability to edit mail, invoice

This hidden course should be displayed near the Upgrade section in the user dashboard.

Admin Upload Options:

Upload course videos

Upload course thumbnails

Add external links (Instagram, YouTube, Google Drive, etc.)

Videos and links must play directly on the site, not open in a new tab/window.

Add a form section at the top of the hidden course page:

Users should be able to fill the form.

Course videos should appear below the form.

---

◆ USER COURSE SECTION – Certificate System

Update the template with exact fonts, font sizes, spacing, and layout matching the provided certificate.

Admin must have the ability to:

Upload a new certificate template anytime

Adjust font positions (move up/down/left/right)

Make layout changes without developer assistance

---

- ◆ ADMIN KYC SECTION – Enhanced Verification Panel

When a KYC request is submitted, admin should be able to see:

- ✓ Account holder name
- ✓ Bank account number
- ✓ Bank/Branch name
- ✓ IFSC code
- ✓ Profile photo
- ✓ Aadhaar front,back
- ✓ PAN front,back
- ✓ Bank Passbook image

All data must be visible in one single view, without opening individual user profiles.

Admin should be able to approve/reject KYC directly from this section.

---

- ◆ HOME PAGE – Festival Banner Management

Admin should be able to upload:✓ GIF✓ Photo✓ Video

These banners will appear dynamically on the homepage for special occasions with separate section (e.g., Deepawali, Independence Day). Admin must be able to edit/update anytime

---

- ◆ PAYOUT SECTION – TDS (Tax Deduction) Feature

Add a TDS ON/OFF toggle in the payout settings.

When TDS = ON →

System should allow admin to select custom TDS percentage (1%, 2%, 3%, or 5%).

TDS must be deducted automatically before payout.

Show the final payable amount after deduction.

A custom email must be sent when TDS is applied:

Weekly earnings

TDS deducted

Final credited amount

If only active income exists → do NOT mention passive income.

When TDS = OFF →

Use standard payout mail template and normal payout logic.

Add a dedicated section to track total TDS deducted per user.

Admin must be able to edit/update anytime

- ◆ USER SECTION – Marketing Materials Library

Add a “Marketing Materials” section near Webinar & Live Offers.

This section must include:

Script (with copy to clipboard option)

Caption (with copy option)

Image (with download option)

Video (with download option)

Admin must be able to edit/update anytime

This will help users access all official marketing content.

---

- ◆ COURSE ENROLL SECTION – Demo Preview System

When the user clicks Enroll, open a new dedicated page.

A partial demo video should auto-play/Not Play Redirect to Enroll Page (limited duration).

To watch the full video, the user must enroll in simpler when they click enroll page.

After clicking “Enroll,” redirect to:

✓ Payment page,✓ Course access page

Admin must be able to edit/update anytime video thumbnails of particular course

---

- ◆ HOME PAGE VIDEO SECTION – Company Intro Video

The intro video below the banners must play smoothly.

Margins must be perfect, with no extra black space.

Ensure proper responsiveness across devices.

Admin must be able to edit/update anytime

As per Discussed **Shivam Singh** sir ji told in call, we mentioning our requirements as simple as follows:

Registration & Login,Email + Password login,Email verification,Secure password reset,Login history tracking

Profile Section,Personal details,Sponsor / Mentor name,Instagram link (mandatory),Other social links (YouTube, Facebook, LinkedIn),Editable profile photo

KYC Section,User uploads:,Aadhaar,PAN,Bank passbook,Profile photo

Rules:All documents must belong to the same person,Admin approval / rejection required,No payout without KYC approval

Notifications & Emails,Registration confirmation,Purchase confirmation,Payout confirmation,TDS email,Reward emails,Custom email templates

Admin must be able to view:User login history (IP, device, date),Earnings activity logs,KYC approval / rejection logs,Payout approval logs,Admin action logs (who changed what & when)

Mandatory checkbox for users:“I agree to Terms & Anti-Scam Policy

Admin can Export options:CSV,Excel,PDF,Of payout active and passive, TDS, user data which date joined which course payment method like this...etc...for every section we will say if you have confusion

When we click payout done or approve Mail/SMS / WhatsApp integration payout happened automatic

Subscription Lifecycle Management,Auto-expiry handling,Grace period logic,Renewal reminders (email / notification),Restriction of earnings if subscription expired

Admin can:Block Ips,Block devices,Allowlist trusted Ips

Subscription Management,View active, expired, and upcoming subscription renewals,Manually activate/deactivate subscriptions

User can Profile Management,Update personal details,Add social media links,Upload profile photo,View account status (active / under review)

User KYC Submission,Upload required KYC documents,Track approval status,Re-submit if rejected

User Earnings & Wallet,View wallet balance,Income breakup,Transaction history,TDS deduction visibility

Trusted by section eg.. phone pe, razor pay, tech up technologies

Users can request payout only after KYC is submitted and approved,If KYC is not approved, payout request will be blocked,Admin can make payouts without user request:,Manual (advance payment),Automatic (system-based),All payouts (manual or automatic) must be recorded and auditable.,Final payout rules and automation will be discussed and finalized during development.

Admin can create offer/discount coupons during festivals or special campaigns.,Discounts can be applied to:All course prices,Subscription renewals,Course upgrades,Admin can set:,Discount percentage or fixed amount,Validity period,Applicable users or courses

Admin can create live offers for trips or special earning targets,Admin can set:Offer price,Earning/qualification target,Valid time period (start & end date),The offer should automatically activate and expire based on the set time.

Home page popup by admin ....

Home page floating contact/support system set by admin ie. Mail and WhatsApp,OR Both Admin must be able to edit/update anytime

When a user makes a payment for:Courses,Hidden courses,Subscription renewals,the system should clearly show:Base price,GST amount (18%), if enabled,Final total payable amount,GST application will be fully controlled by Admin,Admin can enable or disable GST at any time.

If GST is enabled, 18% GST must be shown and added separately,If GST is disabled, the user will see only the total amount without GST breakup,GST settings can be updated anytime by Admin, based on offers, festivals, or business requirements.

Multiple Admin Payout System – Payout workflows will be discussed and finalized during development.  
Maintenance Page Control – Admin can enable or disable website maintenance mode at any time.

Reels & Freelance Sections – Under Mentor and Instructor modules, Admin can add, manage, and update additional sections as required.Mentor / Instructor Subscriptions & Dashboards – Structure, access control, and features will be defined and finalized during development.

Sales & Financial Dashboards – Admin can view sales data, GST / non-GST breakdown, TDS deducted or not, and export reports in CSV, Excel, or PDF format.user raise tickets to solve their problems.
